Information We Collect

We may collect personal information that you voluntarily provide to us when you:

The personal information we collect may include:

Legal Basis for Processing (UK GDPR)

We process your personal data based on:

- **Consent:** When you provide explicit consent (e.g., subscribing to updates)
- **Legitimate Interests:** For business communications and website improvement
- **Legal Obligation:** To comply with applicable laws and regulations

Sharing Your Information

We do not sell, trade, or rent your personal information to third parties. We may share information with:

- Service providers who assist in operating our website
- Professional advisors (lawyers, accountants) when necessary
- Law enforcement or regulatory bodies when required by law

Cookies and Tracking Technologies

What Are Cookies?

Cookies are small text files stored on your device when you visit a website. They help websites function properly and provide information to website owners.

Types of Cookies We Use

Essential Cookies

These cookies are necessary for the website to function and cannot be switched off. They include:

- Session cookies for website navigation
- Security cookies to authenticate users and prevent fraud
- Load balancing cookies to distribute web traffic

Performance Cookies

These cookies collect information about how visitors use our website, such as:

- Pages visited most often
- Error messages received
- Time spent on pages

All information collected is aggregated and anonymous. We use this data to improve how our website works.

Functionality Cookies

These cookies allow our website to remember choices you make and provide enhanced features, such as:

- Remembering your preferences
- Providing enhanced functionality and personalization

Third-Party Cookies

We may use third-party services that set cookies on our website, including:

Google Analytics: To understand how visitors interact with our website

- Data collected: Pages visited, session duration, device information
- Privacy Policy: policies.google.com/privacy

Managing Cookies

You can control and manage cookies through your browser settings:

- **Safari:** Preferences > Privacy > Cookies

Most browsers allow you to:

- Clear cookies when you close your browser
